

Mauisada Moments Bakery Challenge Contest

Official Rules:

1. CONTEST DESCRIPTION AND ENTRY PERIOD:

The Mauisada Moments Bakery Challenge Contest (the "Contest") starts June 20, 2020 at 12:00 a.m. Pacific Standard time ("PST") and ends September 22, 2020 at 11:59 p.m. PST ("Contest Period"). During the Contest Period, participating stores must submit a photo of their most creative Hawaiian-themed, in-store Mauisada display on either Facebook or Instagram with the hashtag #mauisadamoments and tagging @BakeMark. At the end of the Contest Period, the BakeMark team, using qualified judges, will select one (1) winner based on the image submitted during the Contest Period that best represents the theme of the Contest, which will be judged 50% on originality, 25% on creativity, and 25% on content. The winner will be selected subject to these Official Rules and any terms and conditions. Entry in the Contest does not constitute entry into any other promotion, contest, or sweepstakes. The prize will be distributed to the Facebook or Instagram account holder who submitted the winning photo.

2. SPONSOR:

The sponsor for the Contest is BakeMark USA LLC located at 7351 Crider Avenue, Pico Rivera, CA 90660. This Contest is in no way sponsored, endorsed, or administered by, or in association with Facebook or Instagram. You must abide by Facebook's and Instagram's terms and conditions. You must abide by [Facebook's](#) and [Instagram's](#) terms and conditions.

3. ELIGIBILITY:

The Contest is open only to participating store owners who on the date of entry are legal residents of the U.S.A. and who are at least twenty-one (21) years of age. **The Contest is void where prohibited, including, without, limitation, Colorado, Maryland, Nebraska, New Jersey, North Dakota, Tennessee and Vermont.** Employees of BakeMark and their parents, subsidiaries and affiliates, suppliers, advertising and promotion agencies, and their immediate families (spouse, parents, siblings, and children as well as each of their spouses, regardless of where they live), and persons living in the households of each of these individuals, whether related or not, are ineligible to win in this Contest.

4. HOW TO ENTER:

Participants must purchase at least ten (10) bags of Mauisada Mix from BakeMark. EXCEPT FOR THE TEN (10) BAGS OF MAUISADA MIX AND PROVIDING PROOF OF PURCHASE THEREOF, NO OTHER PURCHASE IS NECESSARY AND NO ENTRY FEE, PAYMENT OR PROOF OF PURCHASE IS NECESSARY TO PARTICIPATE. You must join either Facebook or Instagram in order to participate in the Contest. Facebook and Instagram are free to join. During the Contest Period, participants must submit a photo of their Hawaiian-themed,

in-store Mauisada display on Facebook or Instagram with the hashtag #mauisadamoments and tagging @BakeMark (each photo, a "Submission"). Participants must provide a picture or other evidence of the receipt (as proof of purchase) for at least ten (10) bags of Mauisada Mix purchased by the Participant from BakeMark. **Participants with no receipt will lose eligibility for the Contest.** Submissions will be judged based on the image that best represents the theme of the Contest, which will be judged 50% on originality, 25% on creativity, and 25% on content. The Submission must be posted during the Contest Period. Any photos posted prior to the Contest Period and submitted for the Contest with the hashtag and tag will not be an eligible Submission. Each Participant may only post one (1) Submission. By using the hashtag and/or tagging BakeMark in connection with your Facebook or Instagram post, you acknowledge and agree that BakeMark has the right to stream your post through the Facebook or Instagram API or otherwise use your post as set forth in these Official Rules and the terms and conditions.

All submitted images must be either your own work or submitted with the consent of the photographer/creator/owner and consent of your parent or legal guardian if you are a minor. Your images must not be obscene or otherwise inappropriate. It is your responsibility to ensure that your submitted images do not infringe or violate the intellectual property rights or other rights of any third party or any laws. Your images must not contain brand names, copyrighted material or trademarks, other than those owned by you or BakeMark. By entering your images into the Contest you hereby irrevocably grant to BakeMark, its subsidiaries and licensees, successors and assigns, the non-exclusive, perpetual, royalty-free, no-cost license and right to use and otherwise exploit your name, likeness, biographical information and each submitted image, and all images, text and materials depicted therein, in whole or in part, in any manner or medium now or hereafter known or devised (including, without limitation, streaming media, film, print, interactive devices, mobile media, Internet and on-line systems, digital billboards), throughout the universe and in any and all languages, including, without limitation, the right to display, reproduce, record, perform, exhibit, distribute, copy, edit, change, modify, add to, subtract from, re-title and adapt the same, to combine it with other material, whether relevant or not to this Contest. You hereby forever waive and relinquish all so-called "moral rights" now or hereafter recognized in connection with entries submitted as part of the Contest. Neither BakeMark nor its agents shall be responsible for returning or preservation of the images submitted or for compensating or crediting you in any way. All entries that are posted on BakeMark's social media pages may be available to be viewed by anyone with access to the Internet.

5. WINNER AND ODDS:

There will be one (1) winner for the Contest:

- The winner will receive a travel voucher to Hawaii for two (2) people valued at \$2,500 total.

The odds of winning depend upon the number of eligible Submissions. BakeMark may modify prize conditions at any time in its sole discretion. Prizes are nontransferable. No

cash alternative or prize substitutions are allowed, except in BakeMark's sole discretion. Prizes may not be sold, bartered, or exchanged by the winner. BakeMark shall, in its sole discretion, determine any details of any prize not specified herein.

The winner will receive travel vouchers to be redeemed through Carlisle Travel which may only be used for a trip to Hawaii for up to five (5) nights (awarded as two one-time use travel vouchers with maximum value of \$1,250 per voucher, \$2,500 total). The winner may add people to the trip at their own cost and shall be responsible for any extra charges for an extended stay or upgraded accommodations. If a prize, or any portion thereof, cannot be awarded for any reason, BakeMark reserves the right to substitute a prize of equal or greater value. All federal, state and local taxes on the prizes, and all other costs associated with acceptance or use of the prizes are the sole responsibility of the winner. Arrangements for delivery of prizes will be performed after winner validation. Once the winner has taken possession of the travel voucher, it is their responsibility to contact Carlisle Travel to redeem their prize and organize the travel of their choice. BakeMark will not be involved in the organization of the travel, neither before, during or after the trip.

No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel vouchers must be used by December 31, 2022 or prize will be forfeited. Travel vouchers are subject to the terms and conditions set forth in these Official Rules, and those set forth by Carlisle Travel as detailed in the voucher and ticket contracts. All expenses and incidental costs not expressly stated in the prize descriptions above, including but not limited to, ground transportation, lodging, meals, incidentals, gratuities, baggage fees and personal charges at lodging are the responsibility solely of winner. Travel restrictions, conditions and limitations may apply. BakeMark will not replace any lost, mutilated, or stolen tickets, travel vouchers or certificates.

BakeMark shall not be liable in the event of force majeure or fortuitous events outside its control. BakeMark shall not be liable and no action may be brought against it in the event of incidents demonstrating the characteristics of force majeure such as strike, COVID-19, bad weather etc. which make it partly or totally impossible for participants to take part in the contest and/or for the winner to enjoy the prize.

BakeMark shall in no circumstances be liable for any accidents or incidents that may occur while the winner is using the prize, nor for the loss or theft of the voucher once the winner has taken possession of it. In particular, BakeMark shall be fully, unconditionally and entirely discharged of liability.

6. SELECTION OF WINNER & JUDGING CRITERIA:

At the end of the Contest Period, BakeMark, using qualified judges, will select one (1) winner based on the image submitted during the Contest Period that best represents the theme of the Contest, which will be judged 50% on originality, 25% on creativity, and 25% on content. The winner will be notified via Facebook or Instagram within five (5) days after of the conclusion of the Contest Period. The winner must respond to BakeMark within

seventy-two (72) hours of BakeMark's announcement and must provide a picture or other evidence of the receipt (as proof of purchase) for at least ten (10) bags of Maxisada Mix purchased by the Participant from BakeMark. Failure of the winner to respond to BakeMark within the given time period, or failure to comply with any term or condition herein, may result in disqualification and an alternate winner may be chosen for the next best submission. The BakeMark team has complete discretion over interpretation of the Official Rules and these terms and conditions, the administration of the Contest, and the selection of the winner (subject to the judging criteria). The decisions of the BakeMark team will be binding and final.

7. LIMITATION OF LIABILITY:

By entering or participating in the Contest, you agree for you/yourself, those for whom you are a parent or legal guardian, your agents, representatives, executors, and administrators to (A) release, indemnify, defend and hold harmless BakeMark and its respective officers, directors, and employees (collectively, "Released Parties") from any liability, illness, injury, death, loss, litigation, claim, cause of action, allegation, or damage that may occur, directly or indirectly, whether caused by negligence or not, from the participation in the Contest and/or his/her acceptance, possession, use, or misuse of any prizes or any portion thereof; (B) that Released Parties have neither made nor are in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, with respect to any prize, including, without limitation, to such prize's quality or fitness for a particular purpose; and (C) to be bound by these Official Rules and the terms and conditions and to waive any right to claim any ambiguity or error therein or in the Contest itself, and to be bound by all decisions of BakeMark, which are binding and final. If, for any reason, the Contest is not capable of running as planned (e.g. infection by computer virus, bugs, tampering, unauthorized intervention, fraud, COVID-19, technical failures, or any other causes beyond the control of BakeMark which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest), BakeMark reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest and/or select a winner from all eligible entries received prior to the cancellation. BakeMark reserves the right to correct any typo-graphical, printing, computer programming or operating errors at any time.

9. DISPUTES:

Except where prohibited, you agree that: (A) any and all disputes, claims and causes of action arising out of or connected with the Contest shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office in Los Angeles, California; (B) the Federal Arbitration Act will govern the interpretation, enforcement and all proceedings at such arbitration; (C) judgment upon such arbitration award may be entered in any court having jurisdiction; and (D) unless otherwise prohibited, under no circumstances will you be permitted to obtain awards for, and you hereby waive all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of the Official Rules and these Terms and Conditions, or the rights and obligations of you and BakeMark in connection with the Contest shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules (whether of State of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of California.
